MINUTES OF THE MEETING ON 18 JANUARY 2021 HELD ONLINE VIA ZOOM

The Meeting was called to order at 7:05pm by Chris Knight, the Chair and President of the Association. After brief opening remarks, the Chair called upon Andrew Windler, Treasurer, for his report. Mr. Windler stated that there were no significant changes from the previous month; he reminded Members that dues would be waived for the 2020-21 season and that all members should ensure that their 2021 USL memberships were paid.

Following the Treasurer's report, the Chair recognized Ken Singer, Assigning Secretary. Mr. Singer discussed early season procedures; as part of that discussion, he requested that Members check the 'Ready To Be Assigned' option in Arbiter if they were working this season, and to leave that option unchecked if they was not working this season. He also announced scheduling for a small tournament in February.

Mr. Singer then moved approval of the January Minutes subject to corrections in attendance; the motion was seconded by Keith Denebeim and approved by voice vote.

Adam Curtis, Youth Assignor, updated the Members on youth contract status, and outlined his assignment procedures, stating that both self-assign and assignor-assigned games would be available.

Mr. Denebeim, Lead Trainer (along with others), reviewed the currents status of Mechanics for the upcoming season. These included no shot clock or NCAA goal mouth rules, faceoff procedures, faceoff violators serving their own penalties (no inhome serve), and that on out-of-bounds plays, the player must pick up the ball from the ground. An overview of current expectations on COVID-19 procedures was provided.

The Chair called for New Business. After hearing none brought to the floor, the Chair closed with some remarks. Following the remarks, it was moved (Mr, Curtis) and seconded to adjourn; the motion carried by voice vote and the Chair adjourned the meeting at 7:41pm.
