

## CTLOA – CTYLL AGREEMENT

This Agreement is made by and between:

In this Agreement, the party who is contracting to receive the services shall be referred to as **CTYLL**, and the party who will be providing the services shall be referred to as the CTLOA.

1. **DESCRIPTION OF SERVICES:** The CTLOA will provide the following services, (collectively, the “Services”).

- Designate an appropriate representative of its Association to work as the Officials Assignor.
- Assign officials for all **CTYLL Regular Season & Post Season Play** (the “League”)
- Provide officials who will officiate the games according to the rules of play established by the League Administration.
- Provide only officials who meet the following criteria:
  - US Lacrosse Member in Good Standing; and
  - Have met the CTLOA requirements for annual training and eligibility to officiate.
- Communicate all schedule changes to officials immediately upon receipt of changes and/or as weather conditions dictate scheduling changes
- CTLOA will provide Adult and Junior (high school age) CTLOA Members to officiate CTYLA sanctioned games according to the level of official and age group as outlined in Table 1 below.

2. **TERM OF SERVICES:** The CTLOA’s services will begin when this agreement is fully executed and will remain in effect for 1 year.

**3. COMPENSATION AND PAYMENT OF SERVICES:** In consideration for the Services, *CTYLA* agrees to the following terms of payment:

*Assigning* - All games assigned by the CTLOA will be subject to assigning fees of \$6.00 per official per game. This fee will be split between the league assignor (\$5.00) and the CTLOA (\$1.00) for administrative and operating costs.

*Game Fees* – Table 2 below is the CTLOA Fee Schedule and will apply to regular season and postseason tournament play:

**4. PAYMENT:** Assigning fees will be billed to the CTYLA for CTLOA fees during the Spring play according to the following schedule:

- March 31 (Fee for the first half of the season)
- May 15 (Fee for the second half of the season)

If a game is cancelled with more than 24 hours' notice, then no assigning or game fees are due. If cancellation is made with less than 24 hours' notice, then the full game fees for officials are due and owing. The CTYLA will review the number and nature of cancelled game during the season to determine if any exceptions should be made with regards to charging assigning fees for cancelled games already assigned. If a game is suspended, or canceled after the commencement of the game, full payment of the official(s)' fee and Assignor's fee is due and owing.

Official's fee payment is the responsibility of the home team and must be executed electronically. within 72 hours of game completion. Teams can also choose to pay officials by check or cash at the game site during the event. Any other means of payment must be approved by the CTLOA in advance.

**5. RELATIONSHIP OF PARTIES:** The parties understand and agree that the CTLOA, the Officials Assignor, and the Officials that officiate the games are independent contractors with respect to the League and are not employees, agents or representatives of *CTYLA*. The parties understand and agree that the Officials that work the games are independent contractors with respect to the CTLOA and are not employees, agents or representatives of the CTLOA. Further, other than rendering the delineated Services, the CTLOA, the Officials Assignor and Officials that officiate the games are not responsible for the operation of *CTYLA*.

**TAXES:** The CTLOA understands that *CTYLA* may issue or caused to be issued any appropriate tax documents to the extent required by law. The CTLOA acknowledges that the members of its Association have been notified that each individual is solely responsible for the payment of all state and federal taxes, if any, associated with any monies paid by *CTYLA*.

- 6. ENTIRE AGREEMENT:** This Agreement contains the entire agreement of the parties, and there are no other promises or conditions whether oral or written unless attached specifically to this Agreement as an addendum.
- 7. ENFORCEMENT:** This Agreement is performable in Travis County Texas and shall be interpreted under the laws of the State of Texas. The parties agree that should it be necessary for either party to enforce the terms of this Agreement in a court of law then jurisdiction shall be in an appropriate Court in the State of Texas and venue shall be in Travis County Texas. If any provisions of this Agreement shall be held to be invalid or unenforceable for any reason, the remaining provisions shall continue to be valid and enforceable.
