

CTLOA – CTYLA AGREEMENT

This agreement is made between:

In this agreement, the party who is contracting to receive the services shall be referred to as CTYLA, and the party who will be providing the services shall be referred to as CTLOA.

1. DESCRIPTION OF SERVICES: The CTLOA will provide the following services, (collectively, the “services”).
 - Designate an appropriate representative of its association to work as the officials Assignor.
 - Assign officials for all CTYLA regular season and post season play (the “league”).
 - Provide officials who will officiate the games according to the rules of play established by the league administration.
 - Provide only officials who meet the following criteria:
 - US Lacrosse member in good standing; and
 - Have met the CTLOA requirements for annual training and eligibility to officiate.
 - Communicate all schedule changes to officials immediately upon receipt of changes and/or as weather conditions dictate scheduling changes
 - CTLOA will provide adult and junior (high school age) CTLOA members to officiate CTYLA sanctioned games according to the level of official and age group as outlined in Table 1.
 - CTLOA will complete and share game reports for all games with CTYLA. Game reports will include scores, direct contact to the head penalties, ejections, and/or sportsmanship issues.
2. TERM OF SERVICES: The CTLOA’s services will begin February 1, 2024, and will remain in effect for 3 years ending October 31, 2026.
3. COMPENSATION AND PAYMENT OF SERVICES: In consideration of the services, CTYLA agrees to the following terms of payment outlined in Table 2. An official’s fee payment is the responsibility of the home team and must be executed electronically within 72 hours of game completion. Late penalties for past due payments are outlined in Table 3. Teams can also choose to pay officials by check or cash at the game site during the event. Any other means of payment must be approved by the CTLOA in advance.
4. ASSIGNING FEES: All games assigned by the CTLOA will be subject to assigning fees of \$7.00 per official per game. This fee will be split between the league assignor (\$6.00) and the CTLOA (\$1.00) for administrative and operating costs. Assigning fees will be billed to the CTYLA for CTLOA fees for all games once officials have been assigned. Any non-weather related game changes made less than 7 days prior to a scheduled game will incur a \$5 change fee. Assigning fee will be billed according to the following schedule:
 - March 31 (fee for the first half of the season)
 - May 15 (fee for the second half of the season)
5. GAME CANCELLATION: If a game is cancelled with more than 24 hours’ notice, then no official(s)’ game fees are due. If cancellation is made with less than 24 hours’ notice, then the full game fees for the official(s) are due and owing. If a game is suspended, or canceled after the commencement of the game, full payment of the official(s)’ fee and assignor’s fee is due and owing.
6. RELATIONSHIP OF PARTIES: The parties understand and agree that the CTLOA, the officials assignor, and the officials that officiate the games are independent contractors with respect to the league and are not employees, agents, or representatives of CTYLA. The parties understand and agree that the officials that work the games are independent contractors with respect to the CTLOA and are not employees, agents, or representatives of the CTLOA. Further, other than rendering the delineated services, the CTLOA, the officials assignor and officials that officiate the games are not responsible for the operation of CTYLA. The CTLOA understands that CTYLA may issue or cause any appropriate tax documents to the extent required by law. The CTLOA acknowledges that the members of its association have been notified that each individual is solely responsible for the payment of all state and federal taxes, if any, associated with any monies paid by CTYLA.
7. ENTIRE AGREEMENT: This agreement contains the entire agreement of the parties, and there are no other promises or conditions whether oral or written unless attached specifically to this agreement as an addendum.
8. ENFORCEMENT: This agreement is performable in Travis County Texas and shall be interpreted under the laws of the State of Texas. The parties agree that should it be necessary for either party to enforce the terms of this agreement in a court of law, then the jurisdiction shall be in an appropriate court in the State of Texas and venue shall be in Travis County Texas. If any provisions of this agreement shall be held to be invalid or unenforceable for any reason, the remaining provisions shall continue to be valid and enforceable.
